Next you will have the opportunity to watch craftsmen and artists as they create wooden shoes and Delftware at the Wooden Shoe & Delftware Factory. There will be time for shopping as well. Enjoy a leisurely stroll through the Veldheer Tulip Gardens' five million blooms! Be sure to bring your camera to capture this awesome scene!

Day 4 – Fri/May 11th

After breakfast you will check-out of your hotel and then experience a lovely ride through the countryside of Michigan.
